# NOTICE OF FORTHCOMING DECISIONS TO BE TAKEN BY THE EXECUTIVE 1 DECEMBER 2024– 31 MARCH 2025

This notice contains information about matters on which Bedford Borough Council's Executive will take decisions during the period 1 December 2024 – 31 March 2025. For completeness, it also provides details from the previously published Notice of forthcoming decisions as to decisions the Council's Executive will be invited to make during the month of November 2024. Due to the proximity of the timing of those decisions, it may be that decisions for which Notice has been previously given, may now be taken within the period of this Notice.

Under the Local Authorities (Executive Arrangements) (Meetings and Access to Information) (England) Regulations 2012, the Council is required to publish information about any Key Decisions to be taken by the Executive, an Executive Committee, the Mayor or any other member of the Executive (Portfolio Holder) or an officer acting under delegated powers at least 28 clear days before those decisions are taken. The Regulations also require at least 28 days' notice to be given of any intention to exclude the public from a meeting of the Executive or any of its Committees and the reasons for that intended exclusion. This document constitutes the Council's notice for both of these purposes. It includes information about all Executive decisions that are known about at the date on which it was published. Copies of, or extracts from, the documents to be submitted to the decision taker may be obtained from the relevant Contact Officer whose details are included within the following table or from Bedford Borough Council, Borough Hall, Cauldwell St, Bedford, following their publication. These documents will also be made available on the Council's website five clear days before the meeting. Other documents relevant to the matters to be considered may also be submitted to the decision maker.

The Regulations recognise that circumstances may arise where a Key Decision has to be taken urgently and it is not possible to give 28 clear days' notice of that Decision. They also recognise that, on occasion, it may not be possible to give 28 clear days' notice of an intention to exclude the public from a meeting of the Executive or one of its Committees. The regulations set out the procedures which must be followed in such circumstances. These include the need for the Council to publish notices at its offices and on its website setting out the reasons why the matter has to be dealt with more quickly. The Council will follow these procedures whenever the need arises to do so.

In this document, KEY DECISIONS are indicated by the letters **(K/D)** in the subject column. Items for which the public may be excluded from a meeting concerned are identified with an \*. The reasons for any potential exclusion are set out at the end of the document.
